The reviewers had some remaining guidance which they wish the applicants to consider (and upon which approval is not dependent):

 The claim that the clinician's propensity to intervene to support smoking cessation cannot be associated with the index patient's outcome, current CVD, is simply not true. There are examples in the literature that show that physician preference is not random and can still lead to confounded results if it is associated with patient or provider characteristics. E.g. see for a discussion of underlying assumptions and common inadequate reporting in studies using physician preference as an instrumental variable: https://www.jclinepi.com/article/S0895-4356(21)00184-0/fulltext

- Furthermore, the comment about physician preference/propensity to prescribe did not relate to what this means in general, but how it will be defined in this particular study. Prior studies have shown that one gets large variation in point estimates and width of confidence intervals dependent on the exact definition of prescribing preference-based IVs: <u>https://www.jclinepi.com/article/S0895-4356(11)00209-5/fulltext</u>
- Given that the intervention exists of 9 categories, will the study be adequately powered to study different effects by all these different intervention categories? Will certain categories potentially be pooled?
